PRE-ENROLLMENT INFORMATION

1. Average salaries in the United States:

- For a Cosmetologist it is from 35,000 to 40,000 a year. (Offered at all campuses)
- For a Barber it is from 35,000 to 40,000 a year. (Offered only at the Cutler Bay campus)
- For Full Specialist it is from 25,000 to 32,000 a year. (Offered at the West and Cutler Bay campuses)
- For a Massage Therapist it is 33,000 to 47,000 a year. (Offered only at the West campus)
- For a Skin Care specialist it is from 28,000 to 32,000 a year. (Offered only at the Main campus)
- For a Nail Technician it is from 25,000 to 27,000 a year. (Offered only at the Main campus)

2. There are certain physical demands that these professions require, such as:

- Standing for a significantly long time.
- Constantly dealing with the public.
- Constantly working with your hands.

3. There are also certain safety requirements for these professions, such as:

- Using the correct chemicals as well as the correct amount of chemicals.
- Using scissors, knives and other sharp objects.
- Using machinery.

REQUIREMENTS FOR LICENSURE

Licensing requirements for the State of Florida are:

- Cosmetology (Offered at all campuses) – 1,200 hours completed and passing the State Board licensing exam.
- Barber (Offered only at the Cutler Bay campus) – 1,200 hours completed and passing the State Board licensing exam.
- Full Specialist (Offered at the West and Cutler Bay campuses)– 600 hours completed and passing the Full Specialist exam.
- Massage Therapy (Offered only at the West campus) - 500 hours completed and passing the State Board Licensing exam.
- Skin Care Specialist (Offered only at the Main campus) – 260 hours completed and passing the Skin Care licensing exam.
- Nail Technology (Offered only at the Main campus) – 240 hours completed and passing the Nail Tech. licensing exam.

RATIONALE OF ADDITIONAL HOURS

Massage Therapy (Offered only at the West campus)

720 clock hours, 220 clock hours longer than the 500 hours required by the state. The school produced this format because we felt it was important for students to graduate this program with the added practical skills and knowledge needed for a successful transition into the workplace. This extra instruction also increases the chance of successfully passing the State Massage Therapy licensure exam.

Facial Specialist (Offered only at the Main campus)

325 clock hours, 65 clock hours longer than the 260 hours required by the state. The school produced this format because we felt that 260 hours was too little time to cover all the topics and lessons needed. This extra instruction will ensure that no student finishes the program without fully understanding all the key factors of the program.
